CDL Medical Certification Update

Beginning June 23, 2025, the FMCSA National Registry will begin transmitting a driver's medical certificate directly to the State Driver Licensing Agencies (SDLAs). What does this mean for you?

Drivers will no longer be required to submit their Medical Certificate to their SDLA. However, during this transition we will still need you to request a copy of your medical certificate from the clinic and send it to the Safety Dept., until further notice. You will also need to schedule your medical exam well before the expiration date, as there could be a 2-4-day delay, due to turnaround time, before the medical certificate will show up on the MVR.

*Driver will certify their driving tier type (Non-Excepted Interstate) when renewing their CDL.

CSA Points assessed from DOT Roadside Inspections When are CSA points assessed?

If a violation is listed, then CSA points are assessed to both the driver and the carrier. The officer may also issue a citation to the driver, however, if the word "WARNING" appears in the citation column, this means the situation wasn't serious enough to warrant a citation or fines, but the CSA points related to the violation still impact both the driver's and the company's CSA score.

2025 YTD top 3 Log Violations

Inaccurate Duty Status/Time/Location – 176 violations – This includes fuel and load/delivery violations, combined

Inaccurate Miles Listed - 115 violations

Travel Time Not Logged Properly - 103 violations

2025 FAA and TSA changes for traveling with Lithium-Ion batteries
Lithium-Ion batteries can continue to be transported in carry-on luggage, but
not in checked luggage. The major change is FAA/TSA cracking down on the
size of the battery, or the batteries Watt-Hour (Wh).

*Watt-Hour (Wh) Limits:

o Up to 100 Wh: Allowed in carry-on without airline approval.
o 101–160 Wh: Allowed only with airline approval and limited to two spare batteries.

o Over 160 Wh: Prohibited in both carry-on and checked baggage unless shipped as cargo under special conditions.

* How to calculate your batteries Watt-Hour o Wh = Ah * V

o This means: an 18V battery, rated at 5.0Ah has a 90Wh rating

* Using the Milwaukee M18 as an example, here is how Watt-Hour ratings vary by model:


o 3.0 Ah High Output Battery: 72 WH o 2.0 Ah Compact Battery: 36 WH

o 4.0 Ah Extended Capacity Battery: 54 WH

o Cannot be over 6.0 Ah

* The FAA is also suggesting the use of 'fire bags' for storage in carry-on bags

Operation Safe Driver Week is scheduled for July 13-19, 2025, focusing on reducing unsafe driving behaviors across North America.

Overview of Operation Safe Driver Week

Operation Safe Driver Week is an initiative organized by the Commercial Vehicle Safety Alliance (CVSA) aimed at improving road safety by addressing unsafe driving behaviors among both commercial and passenger vehicle drivers. During this week, law enforcement agencies in Canada, Mexico, and the United States will actively monitor and enforce safe driving practices.

Key Details

- Dates: July 13-19, 2025.
- Focus: The primary emphasis will be on reckless, careless, or dangerous driving behaviors, including speeding, distracted driving, and driving under the influence of alcohol or drugs.
- Enforcement Actions: Law enforcement personnel will be on the lookout for unsafe driving behaviors, and drivers caught engaging in such actions may receive warnings or citations.

We all have to share the road. You've heard that one before. The fact of the matter is our roads are only going to get busier.

You spend a good part of your life on the roads. Make sure you're doing so safely. Follow these important safety tips:



Buckle Up

Always wear your safety belt. It is your last line of defense. Remember, seat belts save lives.

Prepare For the Drive

Adjust mirrors and instrument panel lighting, and program the GPS before you hit the road.

Drive Safely

Obey speed limits and traffic signs. Excessive speed reduces your ability to avoid a crash, extends your vehicle's stopping distance and increases the severity of a crash if it occurs. Slow down in bad weather and at construction zones.

Avoid Distractions

Avoid distractions such as adjusting the radio, eating, drinking or other activities that remove your attention from the road.

Be Aware of Other Drivers

Never forget that far too many of the drivers sharing the road with you might be inattentive or driving distracted.

Never Text or Email While Driving

Set your smart phone to the do not disturb setting or put it on silent mode before you start your journey. Texting is the most dangerous distraction, according to a study by the Virginia Tech Transportation Institute. Truck drivers who texted while driving had 23 times the risk of being involved in a crash or a near-crash incident.

In addition, federal regulations prohibit texting and hand-held mobile phone use while operating a commercial motor vehicle in interstate commerce. Drivers caught texting or using hand-held mobile phones are subject to strict fines.

Avoid Aggressive Driving

Don't provoke or allow yourself to be provoked. If another driver is acting aggressively, don't take the bait. Simply ignore them.

Only Make Safe and Necessary Lane Changes

Pick a lane and stay in it for as long as possible. Lane changes increase risk of a crash. When you do have to change lanes, always signal any lane change or turning movement well ahead of the action.

Don't Tailgate

Following too closely reduces visibility of the road ahead and impacts your reaction time.

Allow Plenty of Time

Allow plenty of time to reach your destination so you will be less likely to speed.

Never Drive Under the Influence

Never drive under the influence of drugs or alcohol and watch out for other motorists whose driving behavior suggests they may be alcohol or drug impaired.

Get Enough Sleep

Sleep deprivation and fatigue causes lapses in attention, slowed awareness and impaired judgment.

Don't Multi-Task Behind the Wheel

Glancing away from the road for more than one second – for any reason – can be extremely dangerous. At 55 miles per hour, during a three-second glance away from the road, your vehicle will move nearly 250 feet down the road without your attention; that's almost the length of a football field.

Short glances at vehicle instruments, mirrors, installed communication devices, GPS systems or other technology can be done safety, if these scans are limited to less than one second and are related only to the driving task.
